Dear Lindsey,

Enclosed is a complete accounting of the household and child-related expenses I have paid, together with the share of each category that is yours under our agreement and the Interim Consent Judgment dated January 10, 2025. Household costs are divided equally; school, tuition, and the children's medical, dental, vision, tuition, and school costs are set at twelve percent (12%) — the share ordered by the Consent Judgment, corresponding to your 11.34% share of combined income on the Child Support Worksheet (Exhibit B).

Every figure is drawn from a source document. The enclosed statement itemizes each charge by date, and the proof pack reproduces the underlying bills. Utility amounts use current charges rather than past-due balances so no month is counted twice; duplicates were removed; direct payments I made to you during this period are included as advances to be repaid. Court-ordered child support (Consent Judgment of January 12, 2025; guideline worksheet \$1,011.95 per month) was additionally paid through May 1, 2026, and direct support I provided to our son Eli (approximately \$7,700) is likewise not claimed. The original of any bill is available on request.

Please review the enclosed statement and let me know within thirty (30) days how you would like to arrange payment or discuss any item. I am open to a payment schedule.
